Subject: Newspaper notice for transfer of equity shares to Investor Education and Protection Fund (IEPF) Authority

Pursuant to the provisions of Section 124(6) of the Companies Act, 2013 read with Rule 6 of the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended, Equity Shares in respect of which dividend has not been claimed for seven consecutive years or more shall be transferred to Investor Education and Protection Fund ('IEPF'). Accordingly, Bandhan Bank Limited (the 'Bank') is required to follow prescribed process before such transfer including publishing notice in the leading newspaper in English and regional language having wide circulation informing the concerned shareholders that their names and folio number/ DP ID - Client ID are available on the website of the Bank duly mentioning the website address.

NOTICE TO SHAREHOLDERS

(For Transfer of Equity Shares of Bandhan Bank Limited to Investor Education and Protection Fund)

NOTICE is hereby given in compliance with the provisions of the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended, and various circulars issued thereto, from time to time, by the Ministry of Corporate Affairs (collectively referred as 'IEPF Rules').

Further, it may be noted that pursuant to the amalgamation of GRUH Finance Limited ('GRUH') into and with Bandhan Bank Limited (the 'Bank') with effect from October 17, 2019, all the claims relating to dividend declared by erstwhile GRUH shall be made with the Bank.

In terms of the provisions of Section 124(6) of the Companies Act, 2013, read with IEPF Rules, the Bank is required to transfer all shares, in respect of which, dividend has not been paid or claimed for seven consecutive years or more, to the demat account of the Investor Education and Protection Fund ('IEPF') Authority. Accordingly, equity shares in respect of which, dividend declared for the financial year 2016-17 remains unpaid or unclaimed till July 13, 2024, shall be transferred to the IEPF Authority. However, where there is a specific order of any Court or Tribunal or Statutory Authority restraining any transfer of such shares and payment of dividend or where such shares are pledged or hypothecated under the provisions of the Depositories Act, 1996, the Bank will not transfer such shares to the IEPF Authority.

NOTICE is further given that in accordance with the provisions of the IEPF Rules, individual notices have already been sent to the concerned shareholders, at their latest addresses available with Bank/ KFin Technologies Limited (the Registrar and Share Transfer Agent ('RTA') of the Bank), *inter alia*, providing relevant details of shares due to be transferred to the IEPF Authority. The details of such shareholders, such as, names and their folio number or DP ID - Client ID, is also available on the website of the Bank under the section 'Details of shares due for transfer to IEPF Authority' at <https://bandhanbank.com/unclaimed-shares>.

The concerned shareholders are, therefore, requested to claim the unpaid or unclaimed dividend(s) on or before July 13, 2024, failing which, their shares, along with the benefits accruing on such shares, will be transferred to the IEPF Authority.

The concerned shareholders, holding shares in physical form and whose shares are liable to be transferred to IEPF Authority, may please note that in terms of the IEPF Rules read with Section III of the SEBI Master Circular dated May 17, 2023, the Bank would be issuing Letter of confirmation in lieu of the original share certificate(s) held by them for the purpose of transferring the said shares to IEPF Authority and the said original share certificate(s) shall automatically stand cancelled. After issue of Letter of Confirmation, the Bank will inform the depository by way of corporate action to convert such physical share into demat form and transfer in favour of the IEPF Authority. Further, in case of shares held in demat mode, the transfer would be effected by way of a corporate action to be executed with the concerned depository with necessary instruction to transfer such shares directly to IEPF Authority. The concerned shareholders are further requested to note that all future benefits arising on such shares would also be transferred to the IEPF Authority.

It may further be noted that post transfer of shares and dividend to IEPF Authority, the concerned shareholder may claim the shares and dividend so transferred from the IEPF Authority by making a request to the Bank/ RTA for issuance of 'Entitlement Letter' and sending the physical copy of the requisite documents as enumerated in the web based e-Form IEPF-5 and IEPF Rules, in original, to the Bank/ RTA at the addresses mentioned below, duly signed (as per the specimen signature recorded with the Bank). On obtaining the 'Entitlement Letter', file an online application in the prescribed Web based e-Form IEPF-5 alongwith 'Entitlement Letter'. এতদ্বারা ইনভেস্টর এডুকেশন অ্যান্ড প্রোটেকশন ফান্ড অথরিটি (হিসাব, অডিট, হস্তান্তর এবং ফেরত) আইন, 2016-এর বিধান অনুসারে, এবং মিনিস্ট্রি অফ কর্পোরেট অ্যাফেয়ার্স দ্বারা পরিবর্তিত ও সংযোজিত তৎসহ ভিন্ন ভিন্ন সময়ে জারি করা বিভিন্ন সার্কুলারের বিধান (সংশ্লিষ্টভাবে 'IEPF আইন' রূপে অভিহিত) মেনে এই বিজ্ঞপ্তি জারি করা হচ্ছে।

এছাড়া, এটাও লক্ষ্য করা উচিত যে, গ্রুহ ফাইন্যান্স লিমিটেড ('GRUH') এবং বন্ধন ব্যাঙ্ক লিমিটেড (অতঃপর ব্যাঙ্ক হিসেবে উল্লেখিত)-এর একত্রী করণ প্রক্রিয়ার কার্যকারিতা মেনে নিয়ে 17 অক্টোবর, 2019 থেকে গ্রুহ দ্বারা ঘোষিত ডিভিডেন্ড সন্দর্ভিত যাবতীয় দাবি এখন থেকে ব্যাঙ্ক দ্বারা নির্ণয় করা হবে।

IEPF নিয়মের সঙ্গে পাঠ্য, কোম্পানি আইন, 2013, ধারা 124(6)-এর বিধান অনুযায়ী, ব্যাঙ্ক সেইসব শেয়ার হস্তান্তরিত করবে ইনভেস্টর এডুকেশন অ্যান্ড প্রোটেকশন ফান্ড ('IEPF') কর্তৃপক্ষকে যার সাপেক্ষে শেয়ারহোল্ডাররা পরপর 7 বছর বা তার বেশি সময় কোনও ডিভিডেন্ড প্রাপ্ত হননি বা দাবি করেননি। তদনুসারে, আর্থিক বছর 2016-17-এর ক্ষেত্রে 13ই জুলাই, 2024 ইকুইটি শেয়ারের ডিভিডেন্ডে ঘোষিত না-সেওয়া বা দাবি না-করা ডিভিডেন্ড রাশিটি IEPF কর্তৃপক্ষকে হস্তান্তরিত করা হবে। তবে যদি কোথাও কোনও কোর্ট, ট্রাইব্যুনাল বা সংবিধিবদ্ধ কর্তৃপক্ষ (স্ট্যাটুটরি অথরিটি) দ্বারা এই জাতীয় শেয়ারের হস্তান্তর ও ডিভিডেন্ড পেমেণ্টের বিরুদ্ধে বিশেষ নিষেধাজ্ঞা জারি হয়ে থাকে বা যেখানে এই প্রকার শেয়ার আমানত (ডিপোজিটরিজ) আইন 1996-এর জাওতায় প্রতিরোধিত বা অনুমিত, সেক্ষেত্রে ব্যাঙ্ক IEPF কর্তৃপক্ষকে শেয়ার হস্তান্তরিত করবে না।

આ નોટિસ, ઇન્વેસ્ટર એજ્યુકેશન એન્ડ પ્રોટેક્શન ફંડ ઓથોરિટી (એકાઉન્ટેન્ટ, ઓડિટ, ટ્રાન્સફર અને રીફંડ) રૂલ્સ, ૨૦૧૭, કોર્પોરેટ બાયલોના મંજૂર થયેલા કાર્યાલય દ્વારા સમયાંતરે સંબંધિત અને જારી કરાતા જુદા જુદા પરિપત્રો (સામૂહિક પદ્ધતિ આઈપીએફ રૂલ્સ તરીકે ઉલ્લેખ)ની જોગવાઈઓ અનુસાર આપવામાં આવે છે.

સંબંધિત શેરધારકો, જેઓ ભૌતિક સ્વરૂપમાં શેર ધરાવે છે અને જેમના શેર આઈપીએફ ઓથોરિટીને ટ્રાન્સફર કરવા માટે જવાબદાર છે, તેઓ કૃપયા કરીને નોંધ લે કે ૧૪ મે, ૨૦૨૩ના રોબીના માસ્ટર પરિપત્રના સંક્રાંતિના સાથે વાંચેલા આઈપીએફ નિયમોના સંદર્ભમાં, બેંક ઉપરોક્ત શેર આઈપીએફ ઓથોરિટીને સ્થાનાંતરિત કરવાના હેતુથી તેમની પાસે રખેલા અસલ શેર પ્રમાણપત્ર(ઓ)ને બદલે પુષ્ટિ પત્ર જારી કરવું અને તે મૂળ શેર પ્રમાણપત્ર(ઓ) અપોઆપ રહી જાય જશે. પુષ્ટિ પત્ર જારી કર્યા પછી, બેંક આવા ભૌતિક શેરને ડિમેન્ડ ફોર્મમાં રૂપાંતરિત કરવા અને આઈપીએફ ઓથોરિટીની તરફેણમાં ટ્રાન્સફર કરવા માટે કોર્પોરેટ કાર્યવાહી દ્વારા ડિપોઝિટરીને જાણ કરશે. વધુમાં, ડિમેન્ડ ફોર્મમાં શેરોના કિસ્સામાં, ટ્રાન્સફર સંબંધિત ડિપોઝિટરી સાથે અગાઉનાં મુકવાની કોર્પોરેટ કાર્યવાહી દ્વારા પ્રભાવિત કરવામાં આવશે અને આવા શેર સીધા આઈપીએફ ઓથોરિટીને ટ્રાન્સફર કરવા માટે જરૂરી સૂચના આપવામાં આવશે. સંબંધિત શેરધારકોને વધુ વિનંતી કરવામાં આવે છે કે તે નોંધ કે આવા શેરો પર ઉચ્ચતા તમામ બાવિ લાભો પણ આઈપીએફ ઓથોરિટીને ટ્રાન્સફર કરવામાં આવશે.

આગળ એ નોંધવું જોઈએ કે આઈપીએફ ઓથોરિટીને શેર અને ડિવિડન્ડના ટ્રાન્સફર પછી, સંબંધિત શેરધારક 'હકદારી પત્ર' જારી કરવા માટે બેંક/આરટીએને વિનંતી કરીને આઈપીએફ ઓથોરિટી પાસેથી ટ્રાન્સફર કરાયેલા શેર અને ડિવિડન્ડનો દાવો કરી શકે છે અને મોકલી શકે છે. વેબ આધારિત ઈ-ફોર્મ આઈપીએફ - ૫ અને આઈપીએફ નિયમોમાં દર્શાવેલ જરૂરી દસ્તાવેજોની ભૌતિક નકલ, મૂળમાં, નીચે દર્શાવેલ સરનામે બેંક/આરટીએને, યોગ્ય રીતે હસ્તાક્ષર કરેલ (બેંકમાં નોંધાયેલા અમુકની સાથે મુજબ), 'હકદારી પત્ર' મેળવવા પર, 'હકદારી પત્ર' સહી નિર્ધારિત વેબ આધારિત ઈ-ફોર્મ આઈપીએફ - ૫ માં એનલાઇન ટ્રાન્સફર અરજી દાખલ કરો. શેરધારકને ટ્રાન્સફર વિનંતી કરવામાં આવે છે કે તેઓ આઈપીએફ નિયમો/પરિપત્રો હેઠળ નિર્ધારિત પ્રક્રિયાનો સંદર્ભ આપે અથવા આઈપીએફ ઓથોરિટીની વેબસાઇટ www.epf.gov.in અથવા બેંકની વેબસાઇટ <https://bandhanbank.com/unclaimed-shares> પર જાય.
