Sub: Allotment of Equity Shares of Bandhan Bank Limited (the “Bank”) pursuant to Exercise of Options under Bandhan Bank Employee Stock Option Plan Series 1 (“ESOP Series 1”)

We wish to inform that the Nomination and Remuneration Committee of the Board (“NRC”) of the Bank on January 06, 2023, has approved the allotment of 2,083 equity shares of face value of Rs. 10/- each fully paid-up to eligible employees of the Bank upon exercise of the Options vested with them under the ESOP Series 1.
