Sub.: Intimation under Regulation 29 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Board Meeting to consider Unaudited Financial Results of Bandhan Bank Limited (the 'Bank') for the Quarter ended June 30, 2021.

This is to inform that the Meeting of the Board of Directors of the Bank will be held on Friday, July 30, 2021 at Kolkata, *inter-alia*, to consider and approve the Unaudited Financial Results of the Bank for the Quarter (Q1) ended June 30, 2021.

Pursuant to the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015 and the Bank's Code of Conduct for Prevention of Insider Trading and Code of Practices and Procedure for Fair Disclosure of Unpublished Price Sensitive Information, the Bank has already informed Stock Exchanges vide its letter no. BBL/103/2021-22 dated June 29, 2021 that the window for trading in securities of the Bank for the Promoter(s), Directors, Designated Persons, Auditors and their immediate relatives, and Connected Persons of the Bank shall remain closed from July 01, 2021 till the expiry of 48 hours after the declaration of the financial results for the first quarter (Q1) ending on June 30, 2021 and accordingly, the trading window shall be closed till August 01, 2021 and shall re-open thereafter.

We would also like to inform that post declaration of the aforesaid Unaudited Financial Results, the Bank will host an earnings call with analysts and investors on Friday, July 30, 2021 at Kolkata.
