

## **Leverage Ratio**

The leverage ratio acts as a credible supplementary measure to the risk based capital requirement. The Bank is required to maintain a minimum leverage ratio of 3.50% with effect from October 1, 2019. The Bank's leverage ratio as on September 30, 2023, calculated in accordance with the RBI guidelines is as follows:
